7.1% on a savings account at Citi Handlowy

The CitiKonto holder does not bear the costs of its maintenance and does not pay for:

- debit card service with a multi-currency function

- withdrawals from Citi Handlowy's own ATMs
- the first four withdrawals per month from ATMs of other networks

– three Express Elixir transfers each month.

Customers can also take advantage of foreign currency accounts available in 13 currencies, attractive exchange rates comparable to online exchange offices and offers discounts and rebates in the CitiSpecials program.

In order to take advantage of the promotional interest rate on the savings account, you need to:

- top up CitiKonto personal account with the amount of at least PLN 2000 per month and make at least 1 non-cash transaction with the account card (for the amount of at least PLN 100) in February, March, April, May,

– open a savings account no later than by the end of February 2024.

The promotional interest rate will be granted for each month in which the above conditions are met. You can fill in the application yourself online or leave your contact details to use the help of a Citi Handlowy advisor. 2. Deposit more: 6% on the deposit and 5% on the SuperSavings Account

In total, you can deposit up to PLN 90,000 with a good interest rate in the bank.
